**ACROMECH signs MOU with Green Energy Resources to explore renewable energy opportunities**

- **Green Energy Resources (M) Sdn Bhd is a company with substantial experience in the renewable energy segment**
- **ACROMECH will contribute expertise in controlled environment engineering**
- **ACROMECH and GER will also explore possibilities for Build-Own-Operate (“BOO”) energy projects**

ACROMECH Limited (“**ACROMECH**”, or the “**Company**” and together with its subsidiary, the “**Group**”) today announced that it has signed a Memorandum of Understanding (“**MOU**”) with Malaysian company, Green Energy Resources (M) Sdn Bhd (“**GER**”). Pursuant to the MOU, both ACROMECH and GER shall jointly work together to explore opportunities in the growing renewable energy segment, and may include working together on BOO energy projects, should opportunities arise.

GER is a specialist in the use of alternative energy sources to generate electricity, with an emphasis on the use of green technologies. It has more than twenty years of track record.

The two parties will commit manpower and other resources to explore opportunities in projects involving the generation of electricity using sustainable feedstock (the “**Projects**”). Specific terms for the Projects shall be set out in definitive agreements to be entered into by the parties at a later stage.

Renewable energy plants require precision control of variables such as temperature and moisture. ACROMECH will contribute its expertise in controlled environments engineering while GER will contribute its expertise in green technologies. The two parties may eventually collaborate to build renewable energy plants on a BOO basis.

The MOU shall be valid for a period of six months, subject to further extension by mutual agreement. During this period, the parties shall not enter into any discussions or negotiations with any third party concerning or relating to the development of the opportunities to undertake renewable energy projects.

Commenting on the MOU, **Mr Lim Say Chin, Executive Chairman and Managing Director of ACROMECH** said, “ACROMECH and GER see growing opportunities in the renewable energy segment. ACROMECH’s possible entry into this space builds on our existing niche expertise to potentially create an additional stream of income.”

The Projects are subject to, amongst other things, the execution of the definitive agreements in relation to the above and there is no certainty or assurance that the definitive agreements will be entered into or that the Projects will take place. The Company will make the necessary announcements as and when there are material developments to the above matter and other matters contained in this press release.
