ACROMEC wins sizeable \$19.5 million sub-contract at a new medical building in Singapore General Hospital Campus

SINGAPORE, 3 February 2020 - ACROMEC Limited ("**ACROMEC**", or the "**Company**" and together with its subsidiary, the "**Group**"), an established specialist engineering service provider in the field of controlled environments serving mainly the healthcare, biomedical, pharmaceutical, research and academia sectors, has secured a sub-contract for the supply, delivery and installation of air-conditioning and mechanical ventilation systems at a new 12-storey health and medical care building in the Singapore General Hospital Campus ("Medical Building"). The Medical Building is intended for acute care and it will include an accident and emergency facility, acute medical wards, and isolation rooms.

This media release is made in relation to the Company's announcement of 29 January 2020 on a potential material contract win. The Company is pleased to announce that it has received and accepted a binding letter of intent to award ACROMEC the sub-contract. The scope of work in the sub-contract includes, among other undertakings, the supply, delivery and installation of the building's air-conditioning and mechanical ventilation systems and its supporting infrastructure, an engineered smoke control system, and the integrated building management system.

The project will commence in the second half of the financial year ending 30 September 2020 ("FY2020") and is expected to be completed by December 2022.

Said Mr Lim Say Chin, Executive Chairman and Managing Director of the Group, "This is a sizeable and longer duration project as compared to our other projects which typically runs for less than a year. It will therefore provide more stability and visibility to our revenue, order book and resource planning."

We are pleased to be awarded this sub-contract in the healthcare sector. Our relentless focus on the healthcare industry, which we believe will provide us opportunities, has paid off with this win. We are still working very hard and we look forward to future contract wins in this space.



We are encouraged by our customer's enduring trust in our abilities and we will continue to uphold high quality standards in all our projects." Mr Lim added.

The sub-contract is expected to contribute positively to the earnings per share and net tangible assets per share of the Group for FY2020. To the best of the Directors' knowledge, none of the Directors and controlling shareholders of the Company have any interests, direct or indirect, in this sub-contract, other than through their respective shareholdings in the Company.
