The rationale for the change in shareholding is pursuant to Mr. Goi Chew Leng's acceptance of the provisional allotment of 2,000,000 Rights Shares and Ingenieur Holdings Pte. Ltd.'s intention not to subscribe for its pro-rata entitlement to the Rights Issue, as announced on 5 January 2023.
